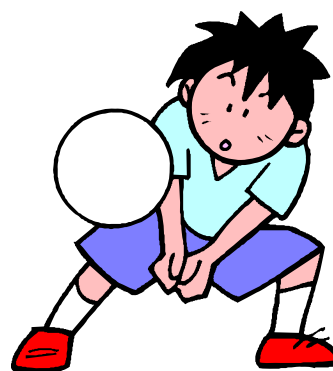
**Middle and Right Side Hitter Training**
